Masinde Muliro University of Science and Technology (MMUST) Ag. Vice Chancellor, Prof. Solomon Shibairo, presented certificates to fifteen (15) staff members who were trained as Integrity Assurance Officers. This was during the 5th Corruption Prevention Committee Meeting held on Tuesday, 19th January, 2021 in the Vice Chancellor's Boardroom.

The five- day training was facilitated by the Ethics and Anti-Corruption Commission from 3rd -7th June 2019 at Jaramogi Oginga Odinga University of Science and Technology. The training covered the following areas:

- i. Identifying and sealing corruption loopholes in the procurement system.
- ii. Promoting integrity in public financial management.
- iii. Attitude change in the fight against corruption.
- iv. Corruption Reporting.
- v. Corruption Risk Assessment.
- vi. Entrenching good leadership and governance in public service.
- vii. Identifying and sealing corruption loopholes in human resource management.
- viii. Fostering organizational culture that promotes ethics and integrity.
- ix. Corruption prevention tools and strategies for public sector institutions.
- x. Psychology of corruption.
- xi. The role of Corruption Prevention Committees and Integrity Assurance Officers in mainstreaming ethics, integrity and anti-corruption.

INTEGRITY ASSURANCE

The University Integrity Assurance Officers (IAOs) are mandated to implement the University's corruption prevention plans, institutionalize corruption prevention, sensitize the University community on corruption prevention, participate in carrying out corruption prevention surveys and corruption risk assessment, identify corruption loopholes and develop mitigation plans to address them.

The Officers were drawn from different Departments and Schools within the University. An inception Workshop on Engineering Curriculum Review, organized by the University's Steering Committee of the Higher Education Partnerships for Sub-Saharan Africa (HEP SSA) programme, was held at the Best Western Kisumu Hotel on Friday, 15th January, 2021. HEP SSA, established by the Royal Academy of Engineering, UK, in 2016, is a project that encourages interaction between academia and industry in order to improve the relevance and skills of engineering graduates. It is supported by the Anglo American Group Foundation and the UK Government through the Global Challenges Research Fund.

The Workshop, officially opened by the Acting Vice Chancellor, Prof. Solomon Shibairo, was spearheaded by the Dean, School of Engineering and the Built Environment (SEBE), Eng. Dr. Bernadette Sabuni, together with the Chairperson of Department, Civil and Structural Engineering, Dr. Micah Mukolwe. During the Workshop, participants were taken through the planned activities of the project, shared experiences on implementation of engineering programmes and how they can be made more pertinent. Industry expectations were also highlighted.

ICT DIRECTORATE IN DRIVE TOWARDS IMPLEMENTING A PAPERLESS SYSTEM AT MMUST

On Thursday, 28th January, 2021, Masinde Muliro University of Science and Technology's Deans and Directors underwent a semi-virtual demonstration-based training organized by the Directorate of ICT on the Paperless Software project. According to the Directorate's Systems Administrator, Mr. Pastor Akhusama, this particular training was the first phase of the ICT's Paperless Software project whose main aim is to ensure digitalization of documents at the University.

"Today, we started by training them on how to write and send Memos electronically. We want MMUST to go paperless and that includes the admission and finance processes. This way, there will be easier movement of documents. Accessing, storing and retrieving them will also be easier not forgetting that it will also save on cost," he said, adding that the response was very positive.

The second phase of this project will be the User-acceptance Testing where ICT personnel will be visiting Departments to physically train staff as they assess the user perception of the software.
